2. GENERAL COMPOSITION

Composition: Blend of natural oils as a water based emulsion.

3. HAZARD IDENTIFICATION

May cause irritation to eyes and skin.

May cause irritation when inhaled.

3. FIRST AID MEASURES

Eyes: Flush immediately with copious quantities of water.

Keep containers closed, in a cool, dry place with adequate ventilation.
